**ANNOUNCEMENTS/PUBLIC COMMENT**

Charles Kaminski inquired on how the Development Services and City Planning Departments track and monitor mitigation associated with projects that have an adverse impact to historical resources. He emphasized that there should be a master list available for the public that indicates the resource and the mitigation measures required and if implemented, on any demolished or substantially altered designated resource that is on the City's register.

Charles Kaminski also commented on the comprehensive Heritage Preservation program website. He was disappointed that it wasn't presented to the HRB, Policy Subcommittee, and the public as it was being developed.

James Walters supports the National Register Nomination for Talmadge Park Estate Historic District.

Katherine Rhoades offered her Historical Resources Research Report template to anyone who would like to write their own.

**BOARDMEMBERS COMMENT**

Chair Hutter shared that Boardmember Abrams discontinued his services with the HRB in December of 2023. Mr. Abrams is very involved in the community we appreciate his involvement and service. Thank you, Bruce.

Boardmember Coyle took time to recognize the annual Governors Preservation Award that she and SOHO will be receiving in recognition of their long-standing service to the community. The project; in which she was a team member along with Rachel Rustin of SDG&E, Brian Williams, and Nick Doose of ASM and Carmen Lucas of the Laguna Indian Tribe; was to do an evaluation on top of Mount Laguna, east of Julian, to be a tribal cultural resource landscape eligible for the National Register of Historic Places. The nomination centered on the Tribal voice, but also used geology, springs, and archaeology as other lines of evidence. It's awarded because the state hopes this can be a model for other tribal communities state-wide who want to put their sacred places on the National Register. Boardmember Coyle is very happy and honored to receive this award on February 24th around 1-3 pm in Sacramento, you can also watch from home.

Suzanne Segur, Senior Planner from the Planning Department, reported that Boardmember Bruce Abrams was appointed in the Spring of 2022, also served on the Policy Subcommittee, and served until December 2023. He will now be spending his newly found free time with his family.

**STAFF REPORT**

Kelley Stanco, Deputy Director from the Planning Department, just wanted to address Mr. Kaminski's non-agenda public comment portion: our preservation and progress initiative has launched. Suzanne Segur, Senior Planner from the Planning Department reported that the appeals of the historical designation of the Lucile Hamilton/Robert Mosher House (HRB Site #1507) located at 485 San Geronio Street and the Frank and Rosa Woodford House (HRB Site #1399) located at 741 11<sup>th</sup> Avenue are tentatively scheduled to be heard by City Council on February 26<sup>th</sup>. Boardmembers are encouraged to attend the appeal hearings to speak on behalf of the Board's action. The appeals of the historical designation of the Donald and Gladys Clitsome/Lloyd Ruocco House (HRB Site #1491) located at 2228 33<sup>rd</sup> Street and the Velma Prichard Spec House #1 (HRB Site #1503) located at 4321 Alder Drive were heard by City Council on December 5<sup>th</sup>. Both designations were upheld. The Botanical Building restoration project in Balboa Park hit a milestone last week when the refurbished cupola was returned to the top of the building's dome. Planning has begun for Phase 2 of the project which includes the restoration of exterior fountains and the reconstruction of a historic pergola.

Suzanne Segur, Senior Planner from the Planning Department reported that a meeting of the Policy Subcommittee was held on December 11<sup>th</sup>. Boardmembers and the public discussed a possible response to the IBA report and the historic district policy for National Register Historic Districts. The January 8<sup>th</sup> meeting was cancelled. The next Policy Subcommittee meeting will be held on Monday, February 12<sup>th</sup> at 3:00 p.m. Staff will be sending out further information within the coming weeks.
