The Commission on Police Practices (CPP) is an independent community oversight body. It provides oversight of the San Diego Police Department (SDPD), investigates officer-involved shootings, in-custody deaths, deaths resulting from interactions with a police officer, and other significant incidents involving SDPD, evaluates complaints against the SDPD sworn personnel, and reviews SDPD policies, practices, training, and make recommendations for changes.

Upon arrival to Building:

- *Enter the building and check in with the front desk security.*
- *Provide security with legal ID.*
 - *Walk-ins: security will contact CPP staff to obtain visit approval .*
- *Security to grant elevator access to the 17th floor.*
- *Ring the doorbell of suite 1725 to inform staff of arrival.*

PUBLIC TRANSPORTATION

Trolley

- **Lines:** Orange or Blue trolley lines.
- **Exit & walking distance:** 5th Avenue station, 2 min walk.
- **Cost:** \$2.50 per trip, or \$5.00 per day.

Bus

- **Routes and Stops:**
 - *From the South*
 - Routes 2 & 6: Broadway & 6th Ave - 5 min walk.
 - Routes 7 & 10: Broadway & 5th Ave - 3 min walk.
 - *From the West* - Route 30: Broadway & 5th Ave - 3 min walk.
 - *From the East* - Route 11: Broadway & 5th Ave - 3 min walk.
 - *From the North* - Route 20: Broadway & 6th Ave - 5 min walk.
- **Cost:** \$2.50 per ride or \$5.00 per day.

PARKING

Procopio Towers Building

- **Address:** 525 B St, San Diego, CA 92101 - No walking required.
- **Rates:** \$16.00 per hour; \$32.00 max per day

Evan Jones Parkade

- **Address:** Civic Center Plaza, San Diego, CA 92101 - 9 min walk.
- **Rates:** \$6.00 per hour; \$18.00 max per day.

Metered Street Parking:

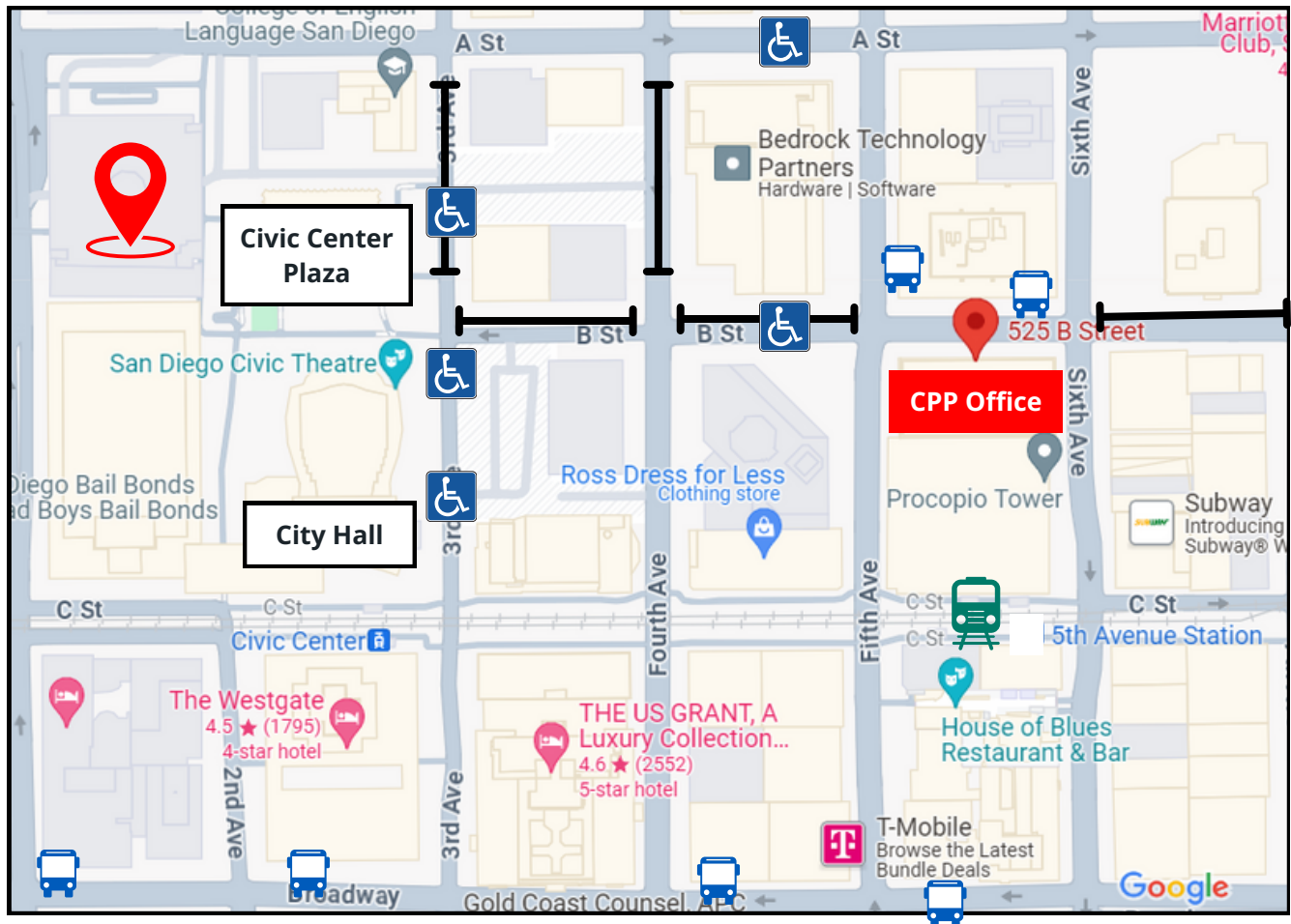
- B St between Fourth and Fifth Avenue - 3 min walk.
- B St between Sixth and Seventh Avenue - 3 min walk.
- Fourth Avenue between A and B St - 5 min walk.
- Third Avenue between A and B St - 7 min walk.

Street Parking for People with Disabilities:

- B St between Fourth and Fifth Avenue - 3 min walk.
- 3rd Avenue between A & B St - 2 min walk.
- A St between 5th and 6th Avenue - 3 min walk.
